INAPPROPRIATE TEST TAKING BEHAVIOR AND COLLUSION

Inappropriate test taking behavior or collusion in any form will not be tolerated by the American Chiropractic Board of Radiology (ACBR). The test examiners and/or their assistants have been instructed to adhere strictly to ACBR policy and procedures. Candidates will be disqualified from taking or continuing their examination or from receiving examination grades if, in the opinion of the ACBR and/or the examination administrator or assistant, any of the statements made upon the application are false; or if the candidate is found to be cheating as evidence by observation or by statistical analysis of the answer sheet; or if the candidate has placed the integrity of the ACBR examination process in jeopardy; or if the candidate has engaged in any activity which would tend to invalidate the examination results. Taking any act or engaging in any communication which gives the candidate an unfair advantage or places another examinee at a disadvantage or places test results in peril shall be construed to constitute inappropriate test taking behavior.

If, in the ACBR's opinion, any candidate is found involved in inappropriate test taking behavior or collusion during the examination process, their examination will be confiscated and they will be suspended from any further testing. Any allowance to sit for future ACBR examinations may be given by the Board upon the outcome of any investigation and due process. Examinees are advised that if they are found participating in inappropriate test taking behavior or collusion on an examination, the training institution certifying their academic hours and the department chairperson who provided a letter or referral and certification of such candidate will be informed of the matter, in writing, by the secretary of the ACBR.
